C. In all cases, Home Care Allowance payments shall be made directly to the recipient or designated representative. The recipient or representative is responsible for paying the designated provider(s) the authorized amount on a regular monthly basis. No portion of the Home Care Allowance may be withheld for the recipient's personal use.

### HOME CARE ALLOWANCE - Colorado Secretary of State

Medical (or Class A) agencies provide services by licensed or certified health care practitioners, such as nurses, occupational therapists and respiratory therapists. Non-medical (or Class B) agencies provide personal care services that assist with activities of daily living, such as bathing, dressing, toileting and, in some cases, housekeeping.
